

# **AiYogi Privacy Policy**

[AiYogi] (the "Company") is committed to maintaining robust privacy protections for its users. Our Privacy Policy ("Privacy Policy") is designed to help you understand how we collect, use and safeguard the information you provide to us and to assist you in making informed decisions when using our Service.

For purposes of this Agreement, "Site" refers to the Company's website, which can be accessed at <a href="https://aiyogi.ai">https://aiyogi.ai</a> or through our mobile application.

"Service" refers to the Company's services accessed via the Site, in which users are able to utilize customized modules from large language models.


The terms "we," "us," and "our" refer to the Company.

"You" refers to you, as a user of our Site or our Service.

By accessing our Site or our Service, you accept our Privacy Policy and Terms of Use, and you consent to our collection, storage, use, and disclosure of your Personal Information as described in this Privacy Policy.

#### INFORMATION WE COLLECT

We collect "Non-Personal Information" and "Personal Information." **Non-Personal Information** includes information that cannot be used to personally identify you, such as anonymous usage data, general demographic information we may collect, referring/exit




pages and URLs, platform types, preferences you submit and preferences that are generated based on the data you submit and number of clicks. **Personal Information** includes your email address, date of birth, marital status, contact information, and all other forms of information, which are gathered by us and third-parties whose software and services we use to provide user experiences.

# 1. Information collected via Technology

To activate the Service you submit certain forms of Personal Information. To use the Service thereafter, you do need to submit further Personal Information which may include anything collected by us or our third party affiliates, including but not limited to OpenAI.

ElevenLabs, VAPI, or any other product, software, or service that we use or that our website links to. In an effort to improve the quality of the Service, we track information provided to us by your browser, our software application when you view or use the Service, and all other forms of information that we might collect. This might include, but is not limited to, the website you came from (known as the "referring URL"), the type of browser you use, the device from which you connected to the Service, the time and date of access, and other information that may or may not personally identify you. We track this information using cookies, or small text files which include an anonymous unique identifier. Cookies are sent to a user's browser from our servers and are stored on the user's computer hard drive.

Sending a cookie to a user's browser enables us to collect information about that user and



keep a record of the user's preferences when utilizing our services, both on an individual and aggregate basis.

The Company may use both persistent and session cookies; persistent cookies remain on your computer after you close your session and until you delete them, while session cookies expire when you close your browser.

# 2. Information you provide us by registering for an account

In addition to the information provided automatically by your browser when you visit the Site, to become a subscriber to the Service you will need to create a personal profile. You can create a profile by registering with the Service and entering your email address, and creating a user name and a password. By registering, you are authorizing us to collect, store, and use your email address in accordance with this Privacy Policy.


# 3. Children's Privacy

We may or may not share your Personal Information with third parties with or without your consent. We do share Personal Information with other companies who are performing





# IV. YOUR RIGHTS REGARDING THE USE OF YOUR PERSONAL INFORMATION


